

Information Notice concerning Protection of Rights and Interests of Foreign Workers

Unfair treatment, including discrimination and human rights violations, shall be prohibited.

①(Terms and conditions of employment) Discrepancies in terms and conditions of employment and delay in payment of wages, i.e. wage discrimination compared to Korean nationals

- Failure to pay the difference in **wage, various allowances** and **retirement allowances** and violation of **minimum wage** by stating, "The company is in difficulties" or "Because you are a foreign national"
- Violation of **recess/work hours** and failure to grant **annual paid leave** by stating, "Too busy with given duties" or "You came to make money after all."

②(Abusive language/assault) Abusive language/assault and harassment in disguise of education and instruction of duties

- **Abusive language/assault and harassment** within workplaces, including swearing or physical attack, under the pretext of failure to follow the instructions
- **Sexual harassment/assault**, including excessive physical contacts within the dormitory or under the pretext of job instruction (training)

③(Industrial accidents) Concealment of industrial accidents occurred and evasion of application for industrial accident compensation

- **Concealment**, including failure to report the outbreak of **industrial accidents** when occupational accidents occur
- **Any acts obstructing the filing for compensation**, including industrial accident insurance, under the pretext of being a foreign national

④(Human rights violations) Various acts of human rights violation outside workplaces

- Offering of **accommodation with an illegal temporary building structure** (vinyl greenhouse, container, etc.), and **deduction of excessive expenses for room and board**
- Violation of basic rights, including restriction of right to transportation, i.e. **seizure of ID and bankbook**

You are entitled to **file a report** if any unfair treatments, including discrimination, ever occur.

"You will be protected in order not to be treated unfairly only because of filing a report."

You are entitled to **change the workplace** in cases of unfair treatments, including discrimination.

- In principle, foreign workers are required to continue working at the workplace with which an employment agreement was executed at the time of entry into Korea; however, **a workplace may be changed in cases where the grounds prescribed by applicable statutes occur.** (3 times for the first 3 years + 2 times for 1 year and 10 months)
- Especially, with regard to **suspension/closure of business, violation of terms and conditions of employment** by an employer, **unfair treatment or violation of standards for residential facilities**, you may change your workplace without any limits on the number of times and **without consent from the employer** after the facts and circumstances are verified.
